NOTES:

1. DEFINITIONS OF CONSUMER CATEGORY

DOMESTIC	<p>This category applies to a property used exclusively for residential living purposes by a single family or for shared living up to a maximum of 8 bedrooms. Fees are based on total monthly consumption.</p>
COMMERCIAL	<p>This category applies to any consumer other than a domestic consumer, including any of the following:</p> <ul style="list-style-type: none"> • Government agencies; • Regional organisations; • Health facilities, including hospitals and clinics; • Businesses; • Education or training institutions; • Religious organisations and churches; • Non-government organisations; • Any property wholly or partly to run a business or generate revenue through trade; • Any commercial property that incorporates a small residential dwelling above a shop; • Any apartment block or other residential housing complex where a single water supply is provided for the entire property; and • Metered standpipe or commercial water tanker operators.

2. ADDITIONAL INFORMATION

- 1) Domestic and commercial water charges include a catchment levy of \$0.40c per kL
- 2) CashWater monthly service charge is \$3.13 per kilolitre and is added to above tariff rates
- 3) Cashwater monthly charges per kilolitre (kL) is based on average monthly consumption of 23kL.
- 4) Monthly service charge for post-paid conventional meter is \$72.43 for domestic customers and \$93.06 for commercial customers.
